SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

SECTION 4: FIRST AID MEASURES

4.1 FIRST AID PROCEDURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

Accidental Release Measures: Refer to other sections of this MSDS for information regarding physical and health hazards, respiratory protection, ventilation, and personal protective equipment. The spill should be cleaned up by qualified personnel. Ventilate the area with fresh air. SECTION 7: HANDLING AND STORAGE

7.1 HANDLING

Keep out of the reach of children. Avoid eye contact. Avoid breathing of vapors, mists or spray. Avoid breathing of dust created by sanding, grinding or machining. Do not eat, drink or smoke when using this product. Wash exposed areas thoroughly with soap and water. Keep away from heat, sparks, open flame, pilot lights and other sources of ignition. Avoid contact with oxidizing agents. Use general dilution ventilation and/or local exhaust ventilation to control airborne exposures to below Occupational Exposure Limits. If ventilation is not adequate, use respiratory protection equipment.

7.2 STORAGE

8.1 ENGINEERING CONTROLS

8.2 PERSONAL PROTECTIVE EQUIPMENT (PPE)
